

### **Key Note Speakers**



#### Michael Hallick Director of Business and Resources, Children's Services, London Borough of Wandsworth

Michael Hallick has built a prominent career in the Local Authority, working in a number of operational and strategic roles in Children's Services. His extensive experience includes managing finances within the SEND system, addressing challenges such as the 2014 statutory changes, the growth in children with autism and severe learning disabilities, and post-Covid pressures in early years.

Michael's strategic initiatives in Wandsworth have been particularly impactful. He has used the pressures of falling school rolls to support the SEND system and school budgets, developed ASD and SEMH resource bases, and converted a closed primary school into an expanded SLD special secondary school. These efforts have halted the growth in independent placements and are expected to reduce costs and inflationary impacts on budgets.

Additionally, Michael has been involved in multiple peer reviews, including those for the Royal Borough of Kingston Upon Thames, Kent County Council, Jersey Councils, Windsor and Maidenhead, and the London Borough of Richmond.



## Tom Goldman Deputy Director for the Funding Policy Unit at the Department for Education

Tom Goldman is the Deputy Director for the Funding Policy Unit at the Department for Education. He oversees work on how the department distributes over £55 billion per annum of revenue funding for the education of 5–16-year-olds (and, for pupils with high needs, 0–25-year-olds), and the early years entitlements for 2-, 3- and 4-year-olds, including the current consultations on proposals for the introduction of a "direct" national funding formula for schools, and updates to the national funding formula for early years. Previous responsibilities have included work on the review of the national curriculum, reform of GCSE and A levels, and the Wolf Review of vocational education. Tom has worked in the DfE (and predecessors) since 1990.

## Jon Andrews Head of Analysis and Director for School System and Performance

Jon Andrews is Head of Analysis and Director for School System and Performance at EPI. He has published a wide range of studies including: 'The performance of multi-academy trusts and local authorities', 'School revenue balances in England', 'Access to special schools in England', and 'Grammar schools and social mobility'. He worked in the Department for Education from 2003 to 2016 as a statistician.



#### Dr William Burns Social Care Policy Advisor – The Chartered Institute of Public Finance and Accountancy (CIPFA)

William is CIPFA's social care policy voice, and he runs the Social Care Network. His work focuses on social care reform, and he has produced thought leadership in the areas of charging reform, children's social care reform, Scotland's National Care Service, and social care funding.

Before joining CIPFA, he was Social Care Finance Lead at the Scottish Government where he was involved in costing a range of social care reform policies stemming from the Independent Review of Adult Social Care. William attained a PhD in English Literature from the University of Glasgow and started studying accountancy during the final stages of his PhD.

#### Ben Bryant Director, Isos Partnership

Ben Bryant is a director of the independent research and advisory organisation, Isos Partnership. Ben specialises in developing approaches to support young people with additional needs. He has undertaken high-profile national research on inclusion, exclusions, AP, additional needs and SEND, and worked with numerous local areas to strengthen aspects of their work around inclusion and SEND. Ben is one of the authors of a major report, published in July 2024 by the Local Government Association and the County Councils Network, on the root causes of challenges within the "SEND system" and what a new approach should look like.



#### Oli Clipsham Director, Newton Group

Oli Clipsham is a Director at Newton. He sits on Newton's Children's and Education Leadership team and is currently leading the delivery of Newton's support to a City Council's Whole Life Social Care transformation programme. ### Joe Miller Associate Director, Mime Consulting

Joe has been involved in education data and policy for almost a decade. Having previously worked in the Welcome Trust's education team, he joined Mime in 2019 where he has led projects for a wide range of public sector organisations. Joe has built a strong understanding of the sector and regularly presents to both local and regional government. He is also often approached by senior education leaders for his insight and guidance. Joe led Mime's recent research to better understand inclusion in London's schools, including developing recommendations for the DfE, Ofsted, local authorities, and schools.

Alongside partners in Wandsworth Council, Joe led the development of Mime's SEND forecasting model, which is now used by local authorities across the country. Joe has also led financial projections and scenario planning projects with several local authorities, including those on the DfE's Safety Valve and Delivering Better Value programmes.

Joe is a UKSA accredited researcher and studied Economics at Cambridge University, followed by an MSc in Public Policy.



### Rory Nethercott Consultant, Mime Consulting

Rory joined Mime in 2021 after working for the NHS and in the third sector on health and social care policy. At Mime, Rory has led several projects for regional partnerships across England, often exploring the growth of SEND needs, as well as implications for funding. Rory brings a strong statistical background and played a key role in the design of Mime's pupil forecasting models. Rory co-authored Mime's recent report, commissioned by London Councils, on inclusion in London's schools.

Rory brings a deep understanding of the wider policy context and wrote our response to the SEND and AP Improvement Plan.

Rory is a UKSA accredited researcher and studied Philosophy, Politics and Economics at Oxford, followed by an MSc in Experimental Psychology.

This workshop will explore how to produce robust and useful cohort forecasts. Rory and Joe will present data and facilitate discussion of:

- The key drivers of the size and makeup of the school age cohort
- 2. The key drivers of demand for specific support services, including SEND and social care
- 3. The latest data in your region

The workshop will also cover where to access data and how to get the most value from publicly available data sources, for example ONS population projections.

In particular, Mime will showcase their SEND forecasting model, built in partnership with Wandsworth Borough Council to help the council with high needs place planning. The tool helped Wandsworth to more proactively plan increasing capacity for SEND places to become less reliant on commissioning expensive independent placements. Rory and Joe will present the findings from Mime's recent project applying the forecasting model to project upcoming SEND need across England.

Throughout, Rory and Joe will encourage discussion in breakout groups. This will include exploring analysis of real data from your region, as well as discussion of both the local and national contexts.

Attendees should expect to leave with a good understanding of the key factors to consider in cohort forecasts, as well as an understanding of the role of underlying assumptions. Attendees will also leave with a better understanding of the overarching population trends in their area, and the implications this will have on school rolls and service demand.

This workshop will build on Mime's research on the inclusion of young people with SEND in schools. In particular, Joe and Rory will present evidence from a large research project, commissioned by London Councils, which:

- Sets out the context, including funding
- Exposes the key funding, workforce and accountability challenges faced by local authorities, MATs, schools and families
- Outlines a definition of inclusion developed in partnership with young people and families
- Presents evidence on the nature of increasing demand for services
- Highlights the benefits of inclusion, to young people and their families, as well as schools and local authorities
- Building on best practice identified, makes clear recommendations for stakeholders to improve inclusion

Rory and Joe will present Mime's analysis of data from the National Pupil Database, outlining what the data can tell us about absence, suspensions and off-rolling. Differences between school types and pupil groups will be discussed.

They will also outline the key takeaways from Mime's interviews and focus groups with local authorities and school staff, as well as young people with SEND and their families.

Throughout, Rory and Joe will present examples of good practice, including innovative flexible funding arrangements, and will facilitate discussion and debate.

Attendees can expect to leave with a stronger understanding of the data on inclusion and some clear examples of good practice.

Ordinarily available provision has emerged as a key concept for trying to define what should be available in all mainstream schools, and articulate more consistent expectations about what they should have done before considering a request for additional or specialist provision.  However, how is this defined? By levels of pupil need? or by the nature of interventions/ provision already in place? And, with an increasing emphasis from Government on mainstream inclusion, how can funding/support be rebalanced to reflect this expectation? There is talk of adjustments between the relative size of the HN and Schools Blocks, but how can that be achieved when HN spend is not static but substantially increasing?  And how can we ensure that any move to funding schools rather than pupils is associated with an appropriate transfer of responsibility?  This workshop will explore different approaches to defining ordinarily provision, and some of their strengths and issues. It will also present models that encourage a stronger culture of local collective responsibility.

#### **Travelling by Train**

The venue is conveniently accessible by train. The closest station is Birmingham Moor Street, about a 12-minute walk away. It is part of the Chiltern Main Line, offering services to London Marylebone. Birmingham New Street Station, with extensive rail links across the UK, is approximately a 15-minute walk from the venue.

From Moor Street Station, head to the right and follow Moor Street Queensway. At the crossroads, continue straight onto Jennens Road. The venue is located on Woodcock Street, to the left off Jennens Road. From New Street Station, follow the exit signs for Moor Street Station, which is about a 5-minute walk, then follow the same directions as above.

#### **Travelling by Car**

For delegates choosing to drive, the venue is easily accessible via the A38, which connects to the Midlands motorway network. The M6, M42 and M5 are all in proximity. The Sat Nav postcode for the venue is B7 4BL.
